GUEST LECTURE FROM ALUMNI

On 14/08/2023 a guest lecture entitled "Role of Safety Pharmacology in drug development" was delivered by Ms. R. Rajeswari, Research scientist, Sugan Life Sciences, Tirupati. The session was focused on industrial methodology of drug discovery and development and how a chemical moiety is converted into drug. She also explained why only three important systems such as cardio vascular system, central nervous system and respiratory system are evaluated for the safety pharmacological studies. She concluded her talk by advising the students to plan for a smaller yet complete methodology and attaining proper skills in the same rather than adding number of animal models.
